**Subject : Directions for switch over to cleaner fuels and restrictions on use of DG Sets to Industries situated in Delhi NCR Region by 30-09-2022.**

Ref # Directions no. 53, 56, 62, 63 and 64 Issued by Commission for Air Quality Management (CAQM) in NCT of Delhi.

Ref # Directions No. 961-1043, 921-960, 905-920 and 1044-46 issued by RPCB, Alwar.

Dear Members,

Commission for Air Quality Management (CAQM) in NCT of Delhi and RPCB, Alwar has issued various directions on restrictions on use of DG Sets and to switch over to cleaner fuels to Industries situated in Delhi NCR Region to control Air Pollution in Delhi NCR Region by **30-09-2022**.

As of now Neemrana comes under NCR therefore RPCB, Alwar approached NIA to make our Member Industries aware about compliance requirements with above mentioned directions and consequences in case of Non Compliances after **01-10-2022**.

**key highlights of directions on Use of DG Sets:-**

- No restrictions on Generators running on LPG/ PNG/ Propane/ Butane/ Biogas.
- Diesel Generator Sets converted to run in hybrid/ dual fuel mode with 70% gas based fuel & 30 % Diesel based and equipped with Retrofitted Emission Control Devise (RECD) having valid certification by 5 agencies authorized by CPCB are allowed to run for maximum 2 Hrs on day basis.
- Generator Sets not equipped in hybrid/ dual fuel mode allowed to run for maximum 1 Hrs on day basis subject to such Diesel Generator Sets equipped with Retrofitted Emission Control Devise (RECD) having valid certification by 5 agencies authorized by CPCB.
- Detail log books required to be maintained for running of such DG's.

**key highlights of directions to switch over to cleaner fuels:-**

- Areas in Neemrana where PNG infrastructure and supply is available compulsory have to switch on to PNG or Biomass fuel by 30.09.2022.
- Areas in Neemrana where PNG infrastructure and supply is not available compulsory have to switch on to Biomass fuel by 31.12.2022.
- Maximum permissible emission standard for Particulate Matter (PM) biomass fuelled Boilers is 80 mg/Nm.
- Industries switching over to Bio fuel on regular basis must apply for CTO to concerned Pollution Board.

As per directions issued, in case of Non Compliance of above Industries shall be closed down and not permitted to schedule their operations.

Hence, members are advised to take appropriate steps and measures to comply with the Directions issued.
